



Spotlight on Lou Baum

I had always known that Lou was a remarkable human being, so full of energy and love for all who become a part of his universe, but I had no idea until I read the information he supplied for his biography that he had accomplished so much. I was overwhelmed when I read what he has done with his life so far, and he is still moving forward.

Let's start at the beginning. Louis Franklin Baum II was born in Springfield, Missouri, August 4, 1937. He attended school in Missouri and wrote that his focus was on baseball. He had hoped to sign and play for a major league team after his graduation from high school. For a while, it looked as though that dream would come true. After his Joplin, Missouri, team won the state title in St. Louis, he had the opportunity to sign a major league baseball contract with the Washington Senators. He went to spring training and then earned a spot with the parent club at the ripe old age of 19. The team had planned for him to play third base when Eddie Yost, the current third baseman, retired at



the end of the 1956 season. Lou was able to play three games, but unfortunately, a drunk driver ended his baseball career. However, he is blessed with the memory of reaching his goal, and he also enjoys the memory of developing a friendship with a remarkable player, Mickey Mantle. They lived next door to each other in Missouri, and their friendship continued and deepened over the years as Mickey continued his career with the New York Yankees.

Lou went back to school and earned a B.S. Degree in Marketing from Kansas State University. After his graduation, he was inducted into the U. S. Army and served for six years, two years of active duty in Germany during the Berlin Crisis and four years in the active reserve. He was assigned to the 6th Missile Battalion, 59th Artillery. During the last eight months of his active duty, he was assigned to the Commanding General's Office as a non-commissioned staff officer. Those were exciting days for Lou. He enjoyed watching how a commanding general went about his daily duties of commanding 325,000 troops in Europe. During his time in that office, he had the privilege of visiting with President John Kennedy when he and the General were discussing critical issues in Europe. On his return to the United States, Lou had the rare opportunity of personally meeting President Kennedy at the White House.

He is married to Vicki Baum, a woman he described as one of the most wonderful and special women on the planet. He has three "super children." Son Steven, 45, is a Senor Forensic Technology Manager for an international company in Dallas. His daughter, Stacey Lyn, 43, is Human Resource Specialist for a large consulting firm in Florida. Daughter Catherine Elizabeth, 25, lives in Euless with her parents. She is one of the sweetest people I know.

As you will read below, Lou has always been service minded. However, let's look at his involvement with ECPAAA. Lou is a graduate of the Charter CPA class which was held in 1995. He wanted to help initialize Community Policing in Euless. Over the years, he has seen many citizens get involved and come together as one huge "family," working side by side with police officers.

Lou enjoyed getting to know the police officers, their families and the command staff during the first class. Although they started class as strangers, they soon became friends and have remained friends over the years. The class decided that it wanted to continue the association and met with Sergeant Mike Brown and Chief Gary McKamie just prior to being graduated. He wrote that their eyes lit up like a Christmas tree when the class told them they wanted to form an Alumni Association. The goal was to share information with all citizens in Euless, and the rest is history.

Lou said that they had a lot of fun during that first class and learned a lot. They shared a lot of laughs with Mike Brown. One of the reasons the Euless CPAAA is so successful is because of the continued support of Mike Brown and Gary McKamie. Community policing was their shared dream, and it began to come true with that first class.

Some of Lou's "rewarding experiences" include

- Being selected by the Fort Worth Star-Telegram as "Man of the Year" in 2003 and being awarded the prestigious Herman J. Smith Award;
- Being selected by our Mayor and City Council as "Volunteer of the Year" in 1999;
- Serving on the Governor's Council for Children with Special Health Care Needs in Austin from 2001 -2003;
- Being honored and awarded the prestigious "Lewis Hine Award" by the National Child Labor Committee, an award given to five individuals per year who improve the lives of children around the free world;
- Serving as ECPAAA president for two terms and serving on the Executive Board multiple times;
- Serving as past president of the Morrisdale Neighborhood Association; and
- Serving on the National Commission on Rare Diseases at the request of President Ronald Reagan in 1988.

When Lou and Vicki went to New York to receive the "Lewis Hine Award," they were accompanied by Mayor Saleh and her husband Ray.

The National Commission on Rare Diseases on which Lou served met in Washington every month for two years. This committee impacted decisions on medical research, health care, medical treatments, professional education needs and public information. Lou served with representatives from the National Institute of Health, the FDA, the Department of Health and Mental Hygiene and the National School of Medicine.

From 1991 – 1993, Lou served on the Consortium on Rare Diseases (CORD) in Washington. He was appointed by the Secretary of Health. This Consortium created and disseminated the First Rare Disease Information Directory and Guidelines for Rare Diseases for the Free World.

While serving Resident Reagan, he had the great opportunity of getting to know him. Lou wrote that the President always had time for you, and was a great listener and was a warm and thoughtful person. Lou wrote that he spoke with authority and confidence and did what he said he was going to do. Lou described Nancy Reagan as the "rock and glue" in that relationship; her personality made the President glow and she was always at his side. The President knew and loved Catherine Baum and was especially pleased that they shared the same birth date, February 6. The President loved all "special children" and encouraged Lou and Vicki to create "The World Life Foundation."

"The World Life Foundation" disseminates information on metabolic diseases to parents and/or patients and assists with ground/air transportation to treatment centers all over North America. Their foundation has secured the lives of over 1000 children since 1991, and the service is free.

Although Lou has long be focused on community service, he has also had a successful working career. He worked for J. C. Penney for 18 years; his last assignment was as District Merchandise Manager for the states of Texas, Oklahoma and Louisiana. He was a vice president of a large area rug manufacturing company for three years. He was a national accounts manager for a large furniture company for 15 years. He served two years as COO with a large health care company in Fort Worth and served for two and a half years a Major Projects Manager for the City of Euless. He is now employed by the Principal Management Group as their Compliance Property Inspector and drives a patrol car for CSS Security in Cottonwood Valley in Irving.

In his "spare" time Lou likes to play a little golf and watch sports, especially his beloved Texas Rangers, Dallas Mavericks and the Cowboys.

In my opinion, we are blessed to have Lou in our mist, and I'm happy to be able to call him a friend.
