Their morning was interrupted by a frantic knock on the wall of their second floor apartment. The young man opened the front door and was met by a wall of flames, which leapt through the door and began to guickly spread. His wife called 911 and begged for help. Suddenly a neighbor threw a large rock through a bedroom window. The couple ran into the bedroom and called out the window for someone to help. As neighbors gathered below, the panicked couple dropped the baby into the outstretched arms of helpful neighbors. Thirty four firefighters from Euless, Bedford, Grapevine and Fort Worth responded to the fire, which had spread to four apartments. Euless firefighter George Buttler was among the first to respond. George was an eight year veteran firefighter at the time. This was the second major fire his crew had fought in the previous five days. George entered the apartment, which resembled a smoky oven and fought his way into the attic to attack the fire. While he thought he was on solid attic framing, one step forward sent George crashing to the concrete two stories below. (Continued page 3)

George would later describe the experience as "I started falling and I quickly thought I'd hit the floor soon, but when I didn't, I knew it was going to be bad". The fall crushed both ankles and broke one wrist. Rushed to the hospital, George endured five hours of surgery requiring two steel plates and sixteen pins to repair the ankles. The injuries required extensive rehabilitation and put his future as a shift firefighter in doubt. However, while doctors and others doubted his return, George was confident he would be back doing what he loved...fighting fires. George spent fourteen days in HEB Hospital, one month at home in a hospital bed, and then six months in a wheelchair. Throughout this recovery period, his thoughts were on his fellow firefighters and his burning desire to return to the fire service. By August of 1990, George had recovered enough to attend the Police Academy, which would prepare him for a career as an Arson Investigator. He graduated in November 1990. George continued to recover, in large part due to his youth and physical conditioning. Against all odds, George returned to the job he loved as a shift firefighter in March 1991. In the years to follow, George has continued to serve the citizens of Euless as a Firefighter and a licensed Arson Investigator. He has also taken on important additional roles as the husband of Kristi Buttler father of two sons Tyler and Austin.

As you join together with your family this Christmas, think of the Fire Fighters and Police Officers who are not with their families. Don't feel sorry for them. They're doing the job they love. They are on duty in service to you.

Identity Theft and You Cindy Carter

What does Identity theft have to do with you? I wondered the same thing when Kathy Haecker kept mentioning it to me. Then I did a little research around the police department, and realized, this IS affecting us right here in Euless! We need to be aware of what identity theft is, and know how to proactively keep unscrupulous people from stealing from us.

According to Tim Curry, Tarrant County Criminal District Attorney, Identity theft occurs when another individual illegally uses or possesses your personal identifying information, good credit, or clean record for their personal gain.

Why would they steal your information? To open charge accounts, order goods or services and bill them to you without your permission, they may even access your personal or business accounts for withdrawals or purchase, secure loans, hide illegal funds, remains, secluded from law enforcement or gain employment by circumventing criminal background checks.

What personal information do they want? They are looking for specific information. Social security number, birth date, drivers license number, mother's maiden name, bank account or credit/debit card numbers, PIN numbers log-on names/I.D.'s, passwords.

How Do I prevent people from getting my personal information? While no one is completely safe from identity theft, there are some simple measures that can be taken to help secure your personal information and guard against identity theft. If someone has stolen your information, catching it early is the key!

Other Tips: Shred Discarded Applications. Install a locked mailbox with a slot. Instruct your credit card issuers not to share or sell your info to others. Review your credit report once a year. Never give personal info over the phone. Don't place your mail in an open container. Remove your name from Marketing lists. Create a log of all credit and Personal information including credit card numbers, customer service telephone numbers, and credit reporting agencies and store in a locked container. Do not write account numbers on envelopes.
