Ms. Jamie Becker earned her B.S. in Chemistry from the University of South Alabama in 1993. She has been employed in Forensic Sciences for twenty-five years, twenty of those years as a Firearm & Toolmark Examiner. She has worked for the Alabama Department of Forensic Sciences in Mobile, AL; the Arkansas State Crime Laboratory in Little Rock, AR; the Florida Department of Law Enforcement Crime Laboratory in Tallahassee, FL; and the Bexar County Medical Examiners Office & Crime Laboratory in San Antonio, TX; prior to her arrival in Fort Worth, TX to work for the Tarrant County Medical Examiner's Office and Crime Laboratory in August 2002.

Ms. Becker is a Certified and Distinguished Member of the Association of Firearm & Toolmark Association (AFTE). She has served on federal and international committees in her discipline and has a vast background on crime guns and ammunition. She has provided court testimony over one hundred and sixty times in federal, district and juvenile court proceedings. Most memorable was being filmed by the Courtroom Television Network, commonly known as "Court TV", while testifying in Tallahassee, FL.

Jamie enjoys the shooting sports, particularly the shotgun shooting sport of Trap (Singles, Doubles and Handicap Events). She won the title of Texas Lady State Champion in 2008 and 2012, currently is the #2 Lady on the State Team, and is ranked in the top 100 Lady shooters in North America in the event of Trap Singles.

In closing he expressed how great the volunteers are and always there to help him and also all the hours that are put in by volunteers. He wants us to expect the best from them and keep raising the bar for his department.

## Spotlight on Doris Hammond

Our new secretary, Doris Hammond, has been kind enough to share some of her life story with us. She was born in Clearfield, Pennsylvania, a farming community. The population of her home town was 45, so everyone knew everyone else. The closeness of the community meant that the residents did not hesitate to help each other. She wrote that her father raised his family to be active members of the community, a lesson she has never forgotten.



She wrote that she had 25 years of marriage to a "wonderful man"

with whom she raised six children; she has been a widow for eight years, but has many cherished memories. She wrote of how she and her husband owned and operated their own 18-wheeler and used it to move Broadway shows between the US and Canada for nine years. Because of this, she was able to see many places and meet a lot of people. She and her husband also traveled a great deal before they invested in the truck thanks to his job as an operating engineer. During those earlier years, they lived in seven states. Doris even lived in a tent for a month while in Wasatch Front in Utah. Her travels have taken her to all but four of the 50 states.

As mentioned earlier, she and her husband raised six children. She now has eight grandchildren living in different parts of the US. She has a sister who lives in Atlanta, Georgia. Her sister is a professional photography, and Doris enjoys spending time with her, her own camera in hand. She still loves traveling, and tries to have her camera with her at all times.

Although she has lived in Euless for 30 years, she still finds gardening a challenge. She wrote that up North, she did not have to cope with clay soil and 100-degree temperatures. In addition to gardening, she also enjoys reading light fiction and watching family movies on TV.

One of her favorite parts of the CPA class was going to the gun range. She wrote that this activity brought back memories of hunting in Pennsylvania. She also enjoyed the session focusing on narcotics and learning about what the illegal drugs were and where they are often hidden. As for our meetings, she would like to have speakers teach us more about narcotics, human trafficking and child abuse, serious problems plaguing our society.

Doris spends a great deal of her free time volunteering; her volunteering activities allow her to help the community and meet new people. She assists the Parks and Recreation Department and has been recognized by them for being the Captain of Camp Hydration for the Komen Three-Day Run for the past five years. She is a Family Coordinator for the Snowball Express. The focus of this event is to enable children who have lost a parent in military service to share Christmas. Texas has hosted this event for the past three years, bringing in 1500 people. Doris had worked as a Reservation Staff Assistant for American Airlines for 26 years, and the knowledge she gained while working in various reservation departments made her a natural for arranging the charter flights with American Airlines that brought the Snowball Express participants to Texas.

Doris is also certified with the Red Cross; she assists the Northeast Tarrant County Kiwanis and gives a helping hand to Big Brothers and Sisters. Her usual form of recognition for her service is a warm smile, so let us all give her a warm smile the next time we see her.
