# CPAANT Liaison — Leah Benoit - January 2017

The meeting was held at the Euless Police Department on January 7th and there were approximately 40 people in attendance representing 12 cities. Thanks to all of the members that dropped off drinks and the delicious food and thanks to the members that attended the meeting and helped clean up afterwards. Our own Sergeant Todd Murphree was the guest speaker and he talked about a murder case from 2012 that recently went to trial. After a missing person report was made on the female October



2012, it was later discovered she was actually murdered in August 2012. Through investigation, including numerous interviews, phone records, and other evidence, the victim was located in November 2012, buried in a field in Kennedale. She was shot multiple times in the head. This case involved drugs, prostitution, burglary, and ultimately homicide. The actual case took over a month of investigation before the body was discovered. The trial took place in September 2016 and resulted in a conviction and sentence of 99 years in the state penitentiary. Todd was awesome and patiently answered questions after his presentation.
