

## **EXECUTIVE UPDATES:**

- 1. Arbor Daze: Leah Benoit mentioned that we worked a total of 603 ¾ hours at Arbor Daze, 125 hours less than last year. Lou Baum thanked everyone that worked. He said that all 15 classes were represented this year. Class 6 had the most workers. Comments were given to Rick Herrold for next year. Lou mentioned that a motor home will be donated next year for those that need to rest. Judy Rick also mentioned that we need to request light colored t-shirts for the volunteers. The dark colored shirts were to hot this year. Lou showed us last year's total of \$6,643.35. Then he unveiled this year's amount \$11,246.40!! We parked over 7,000 cars. This was a record breaking weekend. Leah then read a thank you letter from Rick Herrold. At this time, Leah mentioned that the Board had approved the Association to pay for an Arbor Daze Volunteer Dinner. The dinner will be June 12 at Texas Star and is expected to cost \$1,600.00. Sara Munday made the motion, second was by Faye Stinneford. Approved.
- 2. Lou Baum showed NBC coverage of our new COP car.
- 3. During the By-Laws discussion, Ruth Zavala asked how we contact old members to see if they want to become members again. A few suggestions were made and will be discussed later.
- 4. Geri Sorg mentioned that there will be a Regional Meeting on June 1 in Coppell. Geri would like to take the new COP car.
- 5. Al Simmenroth filled in for Don Martin for the COP update. Only one opening in May, but June ride outs are open. Please get with Al to schedule.

- 6. Sgt. Pavlik thanked everyone for their participation in Arbor Daze. He also mentioned that the COP program will definitely be going from three to two people after we have a training class, which is scheduled for June 6 at 7:00 pm in the Training Room. Training will include Junk Vehicles, Handicap Parking, Suspicious Activity, etc. Sgt. Pavlik also mentioned that the yellow polo shirts and windbreakers will be available soon.
- 7. Sara Munday gave an update on Police Appreciation Week. Build your own sandwiches and sheet cakes were provided for each shift; each officer received a card and goodie bag. Sara also mentioned that we were able to give goodie bags to the Euless Fire Inspectors, who were at the Police Department for continued education.


