Tell me I'm happy when I'm not.


The purple goes to my brain,





# The Question of Civil Liberties . . . submitted by David Mishkin

The major democracies, although capable of fighting terrorism directly, are often hesitant to do so.

The strategies for fighting terror may be considered <u>passive</u> (unobtrusive) vs. <u>active</u> (intrusive) on Civil Liberties.

A system of passive security, for example, in which a potential target is "hardened" against attack and acts both as a deterrence to actually blunt the effects of such attack. This also involves the use of guards, watchmen, security systems and alert civilian population. In Israel, for example, much of the population are reservists in combat units and carry small arms daily. Such measures are relatively unobtrusive & have few consequences of civil liberties of the citizens.

In so vast a country as the United States, the targets of domestic or international terror are almost infinite, limited only by the imagination of the terrorists.

As was demonstrated in the bombing of the federal Building in Oklahoma City & the destruction of the Twin Towers, terrorists can strike an unlimited number of possible targets and the government has no hope of protecting them all. The complex western democracies have little choice but to adopt an active posture against terror. This means actively identifying persons and groups from which terrorists activity is likely to emerge, monitoring the activities of those who advocate violence and using preemptive surveillance, search and seizure, interrogations, detection and prosecution when it becomes apparent that planning for terrorist violence is taking place. Steeped as they are in moral and legal respect for the privacy of the individual, Western Democracies have been hesitant - justifiably so - to use methods which remind them to much of the doings of authoritarian states they so abhor. Every one of the active steps that a democratic state would take constitutes curtailment of someone's freedom to speak, assemble

or practice his religion. It is these kinds of speech, assembly and religious expression which, if properly monitored, would give law enforcement agencies the warning they need in order to head off calamity.

Netanyahu maintains that the governments of free societies charged with opposing terrorism are then faced with a democratic dilemma: if they do not fight terrorism with the means available to them, they endanger their citizens; if they do, they appear to endanger the very freedoms which they are charged to protect.

In the United States such freedoms are scrupulously protected. Many claim that free speech and religious freedom are "absolute" rights. Even the most passionate advocates of civil liberties concede, along with Supreme Court Justice Oliver Wendell Homes, that freedom of expression must stop at "shouting 'fire' in a crowded theater," American law has thus far been resistant to limiting the scope of such exceptions.

The belief that freedom of speech and religion are absolutes that cannot be compromised is tantamount to replacing one kind of violation of rights with another, even worse violation of the same rights. It is evident that terror – inflicted violations of the civil rights of a people may, if attacks are rare, be insufficient to justify serious action; but it is equally evident that there is some point at which terror becomes the bigger threat to citizen's rights & requires unflinching action.

Advocates of absolute civil liberties forget that legally protected freedoms are not ends in of themselves but are the means to ensure the health and well-being of the citizens. The United States Constitution, said Justice Robert Jackson, is not a suicide pact, when such a protected "right" in practice results in the encouragement of terrorist monstrosities ready to infuse other members of society, then it is clear that

such a right has ceased to serve its true end and must be revised or reduced.

The willingness to make hard decisions in the service of democracy is a hall-mark of a mature political culture. As James Madison wrote to Thomas Jefferson, "It is a melancholy reflection that liberty should be equally exposed to danger whether the government has to much or too little power." When it came to matters that endangered the security of the nation, Madison & Alexander Hamilton were unequivocal that the authority of the elective to ensure the security of the nation must take precedence over all other concerns, as they wrote in The Federalist:

...the circumstances that endanger the safety of nations are infinite and for this reason no constitutional shackles can be wisely imposed on the power to which the care of it is committed

...I ack nowledge my aversion to every project that is calculated to disarm the government of a single weapon, which in any possible contingency may be usefully employed for the general defense and security.

It is natural that a society of free citizens should shirk before a path which inevitably involves limiting the very liberties which the society is committed to protect.

Democracies should have a right and a duty to protect themselves in advance against those who would set out to destroy their societies and distinguish their freedoms.
