From the Desk of Chief Mike Brown

What is your favorite part of being a police officer?

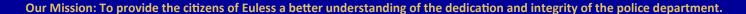

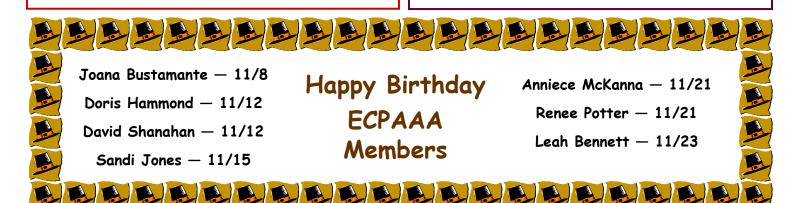
